- The Clerk read the following report from the Police:- Unfortunately the crime figures have increased dramatically over the past month. There were ten crimes recorded in April, however nine of these occurred at the same location. 01/04/15 One report of criminal damage at a property & two reports of assault. 03/04/15 Criminal damage. 18/04/15 One report of criminal damage to a property & two reports of assault. 20/04/15 Criminal damage. 23/04/15 24/04/15 A wing mirror on a vehicle was smashed overnight. There were no witnesses. There were 25 logs reported to the police, including six missing person reports (three from the same location), four vehicle related incidents, one neighbourhood complaint & two alarm activations. There was also a report of an aggressive dog, details of which were passed to the dog warden.
- 11.2 The Chair reported that damage had been caused to the porch entrance to the Parish Hall and it was understood that the new cricket nets and football nets had been vandalised. If anyone sees anything suspicious please report it directly to the police on 101.
- 11.3 TAP Fund as mentioned in item 8 above, Hemyock was successful in its joint bid with Clayhidon and Culmstock and has secured £1,500 towards a shared Parish Lengsthsman. These TAP Fund monies came from the 'underspend pot', money available but not claimed by parishes in previous years. Clerk to arrange a meeting with the other parishes to take this forward.
