Update from Clerk</li> <li>The clerk updated the meeting on the latest developments.</li> <li>A draft contract from the council's solicitors revealed omissions concerning the proposed ransom strip and landscaped areas. The clerk queried this with the solicitor and new information came to light. The council had been dealing with a developer and the solicitor of an owner of adjoining land. It now transpires that the proposed purchaser of the council-owned land intends to sell it on to another party. This party has now made himself known to the council. Mr S Clist then declared a pecuniary interest with relation to this person. Although the council is not selling to this person directly, in the interests of transparency, the interest was noted. Mr S Clist then asked for a dispensation to participate in and vote on all matters relating to this land. He explained he thought it was in the interests of persons living in the parish for him to participate fully in this matter.</li> <li>Mr S Clist left the room whilst the dispensation request was considered.</li> <li>PROPOSAL: in the interests of persons living in the parish, to agree to the dispensation request from Mr S Clist to participate in and vote on all matters relating to the sale of the land.
