- If any election is contested the poll will take place on Thursday, 2 May 2019.
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Phoenix House, Phoenix Lane, Tiverton, Devon, EX16 6PP by 5pm on Monday 15 April 2019.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Phoenix House, Phoenix Lane, Tiverton, Devon, EX16 6PP by 5pm on Wednesday 24 April 2019. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Phoenix House, Phoenix Lane, Tiverton, Devon, EX16 6PP by 5pm on Thursday 2 May 2019. The physical incapacity must have occurred after 5pm on Wednesday 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 24 April 2019.
