CROSS TO GLADHAYES BRIDGE CROSS, HEMYOCK) NOTICE 2021

TEMPORARY PROHIBITION OF THROUGH TRAFFIC

DEVON COUNTY COUNCIL hereby give NOTICE that:

From **MONDAY 13 SEPTEMBER 2021**  
for a maximum of 5 days

Until **FRIDAY 17 SEPTEMBER 2021** (both dates inclusive)

Between the hours of **08:00** and **18:00**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.

**ROAD FROM CULM BRIDGE CROSS TO GLADHAYES BRIDGE CROSS, HEMYOCK**

The alternative, signed, route for vehicles will be via - CLOCKWISE - ROAD FROM GLADHAYES BRIDGE CROSS TO BRIDGEHOUSE CROSS (25302854), CULM BRIDGE ROAD (25301943), STATION ROAD (25301505), ROAD FROM WITBY CROSS TO STATION ROAD (25305831), ROAD FROM PEN CROSS TO WITBY CROSS (25302852), ROAD FROM PENN CROSS TO COMBE HILL (25301479), ROAD NORTH FROM COMBE HILL CROSS (25305829), BLACKDOWN HILL ROAD (39606976), ROAD FROM CLAYHIDON CROSSWAY TO GORTNELL CROSS (25302723), ROAD FROM CLAYHIDON CROSSWAY TO GRAYS CROSSWAY (25306248), ROAD FROM ROSEMARY LANE CROSS TO GRAYS CROSSWAY (25304171), ROAD FROM ROSEMARY LANE CROSS TO BRIDGEHOUSE CROSS (25301521), ROAD FROM CULM BRIDGE CROSS TO GLADHAYES BRIDGE CROSS (25305877). ANTI-CLOCKWISE - REVERSE ORDER OF THE ABOVE.

**HYBRID BUILD AND INSTALLATION, (WITH APPROX. TOTAL 960M, INCLUDING 800M OVERHEAD PIA AND 160M CIVILS EXCAVATION), OF NEW FIBRE OF CABLE AND DUCT WITH ANY REQUIRED ROAD CROSSINGS FOR FIBRE TO THE HOME PROJECT. THIS INCLUDES ANY REQUIRED LATERALS, BOXES, CHAMBERS AND CABINETS.**
